1. 🧳	We are an interested party in this tender, but we are having serious challenges uploading our bid document on e-GP system as the space on the portal can only accept a limited quantity of documents. NAPSA has requested for the same items on all the Lots and this is consuming tender space if you are participating in all the tender Lots. For instance, NAPSA has requested for Audited Financial reports for two years. Each set has 60 pages, which translates to 1,080 pages for all the 9 Lots. Kindly guide on how we can save space so that we can participate in all the tender Lots?	Bidders are advised to submit all the requested information as per tender requirement. However, on bulky tender requirements such as financial statements, volumes of service, experience etc, bidders are requested to refer to documentation submitted in Lot 1 where the system cannot allow more space to load similar documents for other subsequent Lots.

The above clarifications in response to queries raised by bidders shall be an integral part of the solicitation document and shall be applied in the evaluation criteria.
