- **4.** The bidding documents may be purchased by interested bidders **with NCC Certificate**, **Category R, Grades 2 and 3** from the National Pension Scheme Authority, 1<sup>st</sup> Floor, Levy Business Park Office Block, Corner Kabelenga and Church Roads, P.O Box 51275, Lusaka upon payment of a non-refundable fee of **K1000.00** or its equivalent.
- **5.** Bidders will be evaluated based on the Preferential Procurement Margin Clause for bidders registered with the Citizen Economic Empowerment Commission (CEEC) as follows:

For a citizen influenced company, by 4% (four percent) For a citizen empowerment Company, by 8% (eight percent); and For Citizen influenced Company, by 12% (twelve percent)

- 6. The bid must be accompanied by a bid security of not less than 2% of the bid sum, duly signed and sealed by the Guarantor and shall be valid for a period of 90 days after bid opening or a 3 years' bid securing declaration.
- 7. Sealed and bound bids clearly marked "Tender for Resurfacing and Reconstruction of Levy Business Park Parking Lots Lusaka" must be deposited in the tender box on the Ground Floor, Levy Business Park Office Block, Corner of Kabelenga and Church Roads, Lusaka, on or before Friday, 20th July, 2018 at 10:30 hours local time. LATE, FAXED AND ELECTRONIC BIDS WILL BE REJECTED. Tenders will be opened thereafter in the presence of bidders or their representatives who choose to attend.
