Sealed and properly bound bids must be deposited in the Tender box situated at the Ground Floor, Levy Business Park Office Block, Corner of Kabelenga and Church Roads, Lusaka, clearly marked, "Provision of property management services for various NAPSA properties on a one (01) year running contract subject to renewal for another year based on performance" addressed to the Director-General and must be received not later than Friday 24<sup>th</sup> August 2018 at 10:30 Hours local time.
