



INVITATION FOR BIDS

1. The National Pension Scheme Authority (NAPSA) wishes to engage firms to provide maintenance and servicing of Levy Business Park equipment on a one-year running contract, subject to annual review and renewal based on satisfactory performance, as follows:

4. The Bidder is allowed, at its option, to bid for individual Lots or for a combination of Lots, but in each Lot, Bidder must quote for all requirements

Bids shall be valid for a period of *90 days* after Bid closing and must be accompanied by a Bid Security amounting to two percent (2%) of the bidder's bid price or a Bid Securing Declaration, (the suspension period should be Three years).
