INVITATION FOR PROPOSALS

NAPSA/DI/18/19: PROVISION OF TRANSACTION ADVISORY SERVICES FOR THE LISTING OF THE LEVY BUSINESS PARK HOTEL ON THE LUSAKA SECURITIES EXCHANGE.

- 1.0 The National Pension Scheme Authority (NAPSA) has set aside funds in the 2019 budget for the provision of Transaction Advisory Services for the listing of the Levy Business Park Hotel on the Lusaka Securities Exchange and intends to apply the funds to eligible payments under the contract for which this Request for Proposals is issued.
- 2.0 Open National Selection (**ONS**) procedures as specified in the Public Procurement Act of 2008 and the Public Procurement Regulations of 2011 will be used and is open to all eligible **Local** Consultants. International Consultants who wish to participate **MUST** Partner with Local Consultants.
- 3.0 It is not permissible to transfer this invitation to any other firm that has not eligibly obtained the RFP document.

- 5.0 Consultants will be evaluated based on the Preferential Procurement Margin Clause for Consultants registered with the Citizen Economic Empowerment Commission (CEEC) as follows: Citizen influenced company, by 4% (four percent) Citizen empowered Company, by 8% (eight percent); and Citizen Owned Company, by 12% (twelve percent).

- 6.0 A firm will be selected using the **Quality and Cost-Based Selection** procedures and in a Full Technical Proposal (FTP) format as described in this RFP.
