

NAPSA/DI/20/19: PRE-QUALIFICATION OF CONTRACTORS FOR THE CONSTRUCTION OF LOW COST HOUSING UNITS IN SOLWEZI, CHITAMBO AND CHINSALI DISTRICTS OF ZAMBIA (UNDER RESERVATION SCHEME)

## 1.0 BACKGROUND

National Pension Scheme Authority (NAPSA) was established through an Act of Parliament, the National Pension Scheme (NPS) Act number 40 of 1996. NAPSA was established to provide income security to the members when they reach retirement age or become incapacitated, or to their spouses and children (biological and legally adopted) in the event of death.

To execute this, NAPSA receives funds and invests the money to generate profitable returns to pay members or beneficiaries reasonable benefits when they become eligible. One of the core mandate is to engaging in strategic investments.

Accordingly, NAPSA intends to undertake development of Low-Cost Housing Units in earmarked towns i.e. 100 housing units in Solwezi; 50 housing units in Chitambo; and 50 housing units in Chinsali under socially and economically targeted investments.

## 2.0 ASSIGNMENT

To successfully construct 100 housing units in Solwezi, 50 housing units in Chitambo, and 50 housing units in Chinsali with associated ancillary works within agreed timeframe and budget.

NAPSA now invites submissions for pre-qualification purposes, for the Low Cost housing units in Solwezi, Chitambo and Chinsali districts, from eligible and qualified **Zambian Local Construction Companies** pursuant to section 63 (1)(b), (2)(a)(c) & (5)(a)(c) of the PPA No.12 of 2008, and sections 23 and 24 of the NCC Act no.13 of 2003.

Qualified and eligible Local Zambian Contractors are free to form Joint Ventures with other capable local or Foreign Contractors to enhance capability pursuant to NCC Act no.13 of 2003 provision as an added advantage. All Joint Ventures must be registered with National Council for Construction.

## 3.0 PRE-QUALIFICATION REQUIREMENTS

Interested Zambian Local Construction firms should provide information demonstrating their possession of the required documentary evidence and relevant experience to undertake the works. Interested bidders are required to provide the following information;

- a) Registration with National Council for Construction in Category B, Grade 1-3;
- b) Valid 2019 NAPSA Compliance Certificate;
- c) Valid 2019 ZRA Tax Clearance Certificate;
- d) Certificate of Incorporation/Registration;
- e) Information on the firm(s) i.e. name, address, telephone, Facsimile and Email;
- f) Evidence of experience in undertaking similar works including names and contact numbers of Consultants and Clients' Representatives who may be contacted for confirmation;
- g) Information on the following key personnel i.e. names, academic qualifications, duly signed off CVs and valid professional membership registration (copies to be provided):
