 The National Pension Scheme Authority (NAPSA) intends to apply part of the budgeted funds to eligible payments under the contract for which this Request for Proposals (RFP) is issued. Payments by NAPSA will be made only at the request of the Authorized Representative, and will be subject, in all respect, to the terms and conditions of the contract.

2. NAPSA now invites sealed proposals to provide the following consulting services (hereinafter called 'services'): NAPSA/DI/24/18: Provision of Consultancy Services on the Market Study for the highest and best use development proposal on the various NAPSA's parcels of bare land - Northern Region under Lots 1 and 2 as follows:

- 5. Bidders will be evaluated based on the Preferential Procurement Margin Clause for bidders registered with the Citizen Economic Empowerment Commission (CEEC) as follows:

Citizen influenced company, by 4% (four percent)
Citizen empowered Company, by 8% (eight percent); and
Citizen Owned Company, by 12% (twelve percent).

- 6. The Consultant is allowed, at its option, to bid for individual Lots or for both Lots, but in each Lot, Bidder must quote for all items.
