

## **INVITATION FOR BIDS**

- 1. The National Pension Scheme Authority (NAPSA) wishes to engage various firms to provide Physical Security Services to Levy Business Park on a one-year running contract basis subject to renewal annually for another two another years based on satisfactory performance.
- 2. NAPSA now invites sealed bids from prospective Bidders who are NAPSA and ZRA registered and compliant, for the provision of physical Security Services to Levy Business Park, Lusaka. The bidders invited as are as follows:

- 4. Bidders are advised that foreign companies will be required to partner with local companies (where applicable). This tender will be subject to CEEC margin of preference and will be applied upon providing proof as follows:
  - a. Citizen Influenced Companies 4 percent
  - b. Citizen Empowered Companies 8 percent
  - c. Citizen Owned Companies 12 percent
- 5. The bidding documents may be purchased by interested bidders from the National Pension Scheme Authority, 3rd Floor, Levy Business Park Office Block, Cnr Kabelenga and Church Roads, P.O Box 51275, Lusaka upon payment of a non-refundable fee of **K1000.00** or its equivalent.

Sealed and properly bound bids must be deposited in the Tender box situated at the Ground Floor, Levy Business Park Office Block, Cnr of Kabelenga and Church Roads, Lusaka, clearly marked, "Provision of Physical Security Services to Levy Business Park on a One (1) Year Running Contract at Levy Business Park in Lusaka subject to review and renewal annually for

another two years based on satisfactory performance" addressed to the Director-General and must be received not later than Friday, 14<sup>th</sup> September, 2018 at 10:30 Hours local time. HOWEVER, TELEGRAPHIC OR TELEFAX BIDS WILL NOT BE ACCEPTED.

- 7. The bids must be accompanied by a bid security of not less than **2%** of the bid sum duly signed and sealed by the Guarantor(s) or a Bid Securing Declaration signed by representative with power of attorney.

The closing date for the receipt of bids is **Friday**, **14th September**, **2018 at 10:30 Hours local time** and any bids received after the time and date stipulated above will not be accepted. The bids will be opened soon after closing at the Meeting Room situated at the **Ground Floor**, **Levy Business Park Office Block**, **Cnr of Kabelenga and Church Roads**, Lusaka; in the presence of bidders or their representatives who choose to attend.
