- 4.0 A bidder is allowed, at its option, to bid for one Lot or all Lots, but in each case bidders must quote for all items and quantities specified for the Lot quoted. Bidders not quoting for the quantities specified for all items in a Lot will be considered as non-responsive. The basis for bid evaluation and contract award will be on individual Lot basis or a combination of all Lots, and NAPSA will award the contract(s) to the most economical and qualitative combination.

5.0 Bidders will be evaluated based on the Preferential Procurement Margin Clause for bidders registered with the Citizen Economic Empowerment Commission (CEEC) as follows:
i. For a citizen influenced company, by 4% (four percent)
ii. For a citizen empowerment Company, by 8% (eight percent); and

iii. For Citizen Owned Company, by 12% (twelve percent)

- 7.0 The bids must be deposited in the Tender Box on the Ground floor, Levy Business Park Office Block, Lusaka on or before Friday 1st March 2019 at 10:30 hours local time. The bids must be accompanied with a bid securing declaration for a period of three (03) years or bid security amounting to two percent (2%) of the bidder's bid price in form of a Bank Guarantee or a Bank Certified Cheque in Zambian Kwacha or in any freely convertible currency.
