TENDER FOR RECONSTRUCTION AND EXTENSION OF THE CAR PARK AT CHIPATA PROVIDENT HOUSE

1. NAPSA has set aside funding for the rehabilitation of various properties and intends to apply part of the funds to cover eligible payments under the Contract for the proposed Reconstruction and Extension of the car park at Provident House in Chipata.
2. Bidding will be conducted using the Open National Bidding (ONB) procedures specified in the Public Procurement Act of 2008 and the Public Procurement Regulations of 2011, and is open to all Bidders eligible as defined in the Bidding Documents.

The bidding documents may be purchased by interested bidders with NCC Certificate, Category R or C (Grade 4-5) from the National Pension Scheme Authority, 3rd Floor, Levy Business Park Office Block, Corner Kabelenga and Church Roads, P.O Box 51275, Lusaka upon payment of a non-refundable fee of **K500.00** or its equivalent.
5. The bid must be accompanied by a bid security of not less than 2% of the bid sum, duly signed and sealed by the Guarantor and shall be valid for a period of 90 days after bid opening or a bid securing declaration.
6. Sealed and bound bids clearly marked **“Tender for the reconstruction and extension of the Car Park at Provident House in Chipata.”** must be deposited in the tender box on the Ground Floor, Levy Business Park Office Block, Corner of Kabelenga and Church Roads, Lusaka, on or before **Monday, 30th January, 2017 at 10:30 hours local time. LATE, FAXED AND ELECTRONIC BIDS WILL BE REJECTED.** Tenders will be opened thereafter in the presence of bidders or their representatives who choose to attend.
