## CONDITIONS

- 1. Indicate at least three (05) similar contracts with traceable references in the past 5 years
- 2. Evidence of being in the similar business for the past 5 years
- 3. Attach Copy of Certificate of Incorporation
- 4. Bidders must have Tax Clearance for 2016
- 5. Bidders must be registered with Zambia Public Procurement Authority (ZPPA)
- 6. Bidders MUST attach copies of the 2016 NAPSA compliance Certificate.
- 7. A Compliance certificate **MUST** be obtained from the Lusaka Area Office, Lusaka House, Corner of Lumumba and Benbella Roads, Lusaka or any **nearest** NAPSA Office.
- 8. All bids must be accompanied by a bid security of not less than 2% of the bid sum provided for in the bidding documents or Bid securing declaration form duly completed and signed.
- 9. Bidders must submit three copies and one original bidding documents
- 10. Delivery period of 6 weeks shall be preferred

Bidders will be evaluated based on the Preferential Procurement Margin Clause for bidders registered with the Citizen Economic Empowerment Commission (CEEC) as follows:

- I. For a citizen influenced company, by 4% (four percent)
- II. For a citizen empowerment Company, by 8% (eight percent); and
- III. For Citizen Owned Company, by 12% (twelve percent)
